There is good news and bad news about the number of subscribers. The good news is that 401 people have subscriptions now in force. The bad news is that is 19 fewer than April of 1999. The magazine is 99 subscribers away from the break even point.

This issue has 32 pages. Eight pages were eliminated to cut cost. I hope these eight pages can be restored and perhaps

another added within the next 12 months.

1st Brigade Engages In Their First Major Battle Since Arrival

morning hours of September 18, a 250-man force of the U.S. Army's 101st Airborne Division landed on a Viet advantage and can win. With battalion headquarters Cong some 800 Comnumbering munists. > Finding themselves in the midst of a force almost four times the size of their own contingent, the Airborne troopers quickly proved their mettle, systematically clearing trenches and engaging the Viet Cong in hand-to-hand combat,

Americans called for air and ground support. Artillery blasted targets from several miles away as fighter bombers swooped in to pound enemy emplacements. The battle raged throughout the day and night until what was left of the Viet Cong force stole away; the Americans then directed their fire to possible evacuation routes.

With the apparent Viet Cong defeat and the capture of the Communists' flag, a small contingent of 101st troopers had proven once again that the American soldier is a dedicated and efficient fighting man--capable of overcoming almost insurmountable odds in the defense of freedom.

1st Brigade gathers

Vietnam veterans receive recognition

Visiting with friends he hadn't seen in 33 years, Vietnam veteran Michael Frieze joined hundreds of his former Fort Campbell colleagues in a ceremony honoring the 1st Brigade, 101st Airborne Division — the third ground unit deployed to Vietnam in 1965.

"It's emotional, especially when people bring up memories of those who have died," Frieze said.

The unit departed July 29, 1965, sailing on the USNS General Leroy Eltigne.

After a ceremony honoring several distinguished members Friday morning, different types of air craft were demonstrated, soldiers performed an air assault demonstration and rappellers drew applause from nearly 1,000 onlookers.

Watching a demonstration by the current 1st Brigade, 101st Airborne Division (Air Assault), Frieze was impressed at the changes in equipment.

The new weapons systems and vehicles are "very high-tech," he said.

However, he said, the tactics the soldiers now employ mirror those Frieze and his friends used in the war.

The sight of soldiers crawling through tall grass firing their weapons as in combat image elicited his memories of Vietnam. One thing he remembers clearly is the fear.

"It was very scary going into a country and not knowing what was there, and suddenly having to use all the training you had," he said.

And that experience forged the strong ties the men share.

"There's a great feeling of camaraderie between those who've gone to war together. We all have a common bond," Frieze said.

Seeing old pals was like a family reunion, although he admitted he didn't immediately recognize some guys. The hair now is gray. They've put on a little weight.

During the demonstrations, groups of camouflaged soldiers showed off new equipment and ended up getting history lessons in return.

Assistant gunner John Hollis

said the veterans were inquisitive, with questions about the mortar equipment he was demonstrating. They would start to tell him how much the equipment has changed and then go into stories about the old days.

"We talk and they listen," Frieze said. "I think they just like to hear the old stories and how it was back when."

Former commander Gerry Morse earned the attention of a group of young soldiers as he shared his war stories.

He traveled from Arizona for the reunion, and was honored there as a distinguished member of the force for commanding the 1st Battalion, 327th Infantry Regiment. The framed certificate he received, he said, was "for the whole battalion. I wanted them all up there with me, but there was only one chair," he quipped.

Every other year, he goes to similar reunions around the country.

"We had a family. These are lifetime relationships. When you join the 101st, your life is never the same again," he said.

Dear Mr. Worrell - By now you've probably received a box of photos of the various elements of the 2/327 Hqs and HHC in late "Spring" 1966. As CO of HHC, 2/327 Inf at that time, it seemed that pictures of the units, platoons and sections within Hq and HHC for each soldier would be a worthwhile addition to their memories. We had a local Vietnamese photographer come in and take the photos and make enough copies for each soldier. Whether this continued or not after my DEROS in late summer 1966 is unknown. What prompted me to send these in were the pictures Tom Ferguson sent in of his company that were recently published. Of course, Tom and I had been friends, even went on R&R to Hong Kong together, returning just in time for the big battle that was to get the 2/327 the PUC. We both went on to other assignments only to reunite at CGSC at Leavenworth, and be in the same instructional section of about 40 officers. Seeing Tom's company in "Diplomat and Warrior" (which title I'd prefer to keep) prompted me to call him and spoof him a bit before he caught on who it was. It wasn't until my fake accent broke from laughing over a prank we pulled on Tom as CGSC that he recognized his tormentor.

I'll try to find other photos to send if you'd like. The one great photo is of Captain Paul Vallelie and me marveling over

an unexploded NVA hand grenade the morning after the battalion CP had been hit pretty hard in the rice paddies west, as I recall, of Tuy Hoa. The grenade was special as it hit my helmet as the attack began and fell to my feet, unexploded. Our battalion CO took a load of shrapnel in the rear from another grenade and several of us took smaller pieces, we think, from that same grenade. My unexploded grenade (emptied of explosive and fuse) is now on a mount on my desk. Rarely the subject of a war story, but more surprising how few people ask about it, or even what it is.

Best wishes on the journal. It is great, so please keep on with it.

I just responded to RAYMOND E. BENSON, II's request for information on the death of his father, 1st SGT RAY BENSON, Co C, 2/327, in May 1967. I was the company com-

mander when the helicopter on which 1st Sgt Benson was a passenger crashed when taking off from my company's small mountain top resupply LZ. Perhaps spurred by Saving Pvt. Ryan the 101st is gaining more historical recognition. This fall the history channel will present a two-hour documentary on the division and its three wars. And much to my amazement there came a call from a DA historian asking me about aspects of Operation Van Buren. Can any of us remember the names of all the operations we were on? Anyway this historian reminded me that Van Buren was during early 1966 around Tuy Hoa, and OCMH was finally getting around to writing an official multi-volume history of the Vietnam War!

This will be a hard cover "green book" series like the ones of WW II and Korea, both published within a few years of the conclusion of the wars. Why a 25-year lag for VN? Well, the historian who called me hinted that there were too many generals still alive who would object to the implied criticisms that a rigorous history of the "no win" strategy might reveal. The problem, as I see it, is that no general stood up and said this is a no win strategy so let's not pretend it will work.

So there may be some old wounds reopened and finger pointing but not until around 2003 when the history is expected to be completed.

Dear Ivan,

My name is Donald Singleton. I served with Company B, 2^{nd} Battalion, 502^{nd} Infantry, 1st Brigade, 101st Airborne Division from July 1966-May 1967. HHC 2/502 from September 1967-February 1968.

In the October 1998 issue of *Diplomat and Warrior* there was an article written about Specialist Four Dale E. Wayrynen. Dale was in my squad. On the night of May 18, 1967, our platoon was ambushed near Duc Pho, Quang Ngai Province, Republic of Vietnam. Our platoon was assisting in the night evacuation of the wounded from an earlier enemy contact. That night Dale lost his life by throwing himself on a live grenade. He saved my life and the lives of others in our platoon. The same grenade that took Dale's life also wounded me, however if it had not been for Dale's heroism I would not be here today.

I spent the last 32 years trying to locate Dale's family. I just wanted to talk to them, let them know that Dale's actions were appreciated and that he did a good job over in the jungles of Vietnam. After searching for over three decades my search finally came to a close. In November of 1997, I found Ms. Laverne Wayrynen (Dale's mother) and John Wayrynen (Dale's brother).

In March of 1999, Ms. Wayrynen visited me at my home in West Palm Beach, Florida. This was a nice gathering and I was happy to have had the opportunity to meet her after all these years.

I am also looking for anyone who served in Company B, 3rd Platoon. In the past four years I have found three people from this platoon, Winston Georges of St. Croix, VI, Nathaniel Fells of Little Rock, AR, and Dolfey (Doc) Jenkins of Owendaw, SC.




After several minutes of questioning, the woman told all: there were Viet Cong in the village; she was one herself; not only that she would go back in the village and point them out.




TUY HOA — Two armed Viet Cong were spotted escaping the path of a Company "C", 2d Battalion, 327th Infantry, sweep and clear operation in the Tuy Hoa area.

Air Reservations At Reduced Fare Offered To Military On Emergency Leave

WASH. (AFNB) — Six U.S. airlines offering reduced standby fare to military personnel are now providing "confirmed reservations" to individuals on emergency leave orders.

Airlines offering the emergency leave provision are American, Braniff, Continental, Trans-World, Western, and United.

Military passengers must surrender to the carrier a document from "his commanding officer or from the American Red Cross certifiyng the emergency leave," a Military Traffic Management and Terminal Service (MTMTS) spokesman said.

Other airlines are expected to offer similar provisions to armed forces personnel, the MTMTS spokesman explained. Four other airlines—Frontier, Bonanza, Allegheny, and Ozark—offer various reduced rates and standby rules.

MTMTS officials recommend military personnel contact local transportation offices for information on special airline fares and standby rules. It was also recommended that transportation officers maintain liaison with local airline representatives regarding any additional changes.

I SEEN YOU

I remember, I remember....walking off that hill at Dak To, a mere lad of nineteen. I SEEN YOU there, Jim, you were walking at my side. You were covered in blood, the blood of your enemies, the blood of your fallen comrades, it was intermixed with that of your own. No longer was there the glint of youth in your eyes, it was replaced with a somber, empty stare. You said nothing as we walked, there was nothing you could say. You didn't need to utter a word, the hell we barely escaped was still dictating and rolling through our minds.... In this numbed state of mind, one thing and one thing only, did we realize..., that we were forever and irrevocably, changed. The innocence of our young lives was killed, it had died with so many of our fellow soldiers on those jungle covered hills surrounding the Dak Tan Kan Valley.

We had survived, we fought many fierce battles over the past twelve months, but this one, this one, was by far the bloodiest. The carnage, horror and death was incalculable in our young minds. We were stunned, but we were alive, and we had been victorious! We had put in our year. We were going home! To the Land Of The Big PX! We would be able to buy and enjoy whatever our pocketbooks would permit. Our tour was up and the nightmares behind us. We would be able to go and do as we pleased, no more fighting, suffering and dying. Or so we tried to tell ourselves.

Inside we really knew that things would never be the same. We realized that, when we walked off that hill. But still, we didn't want to admit it. There was no way we could predict the unrest and chaos that awaited us in the streets of our hometowns and in our minds.

We were welcomed home, quietly and individually, by close friends and family. We didn't expect any fanfare nor did we get any. We melted into our civilian roles and jobs, as best we could. We watched the war and protests over the television and in our downtowns. There was little we could do as this unrest and division slowly broke our hearts. We watched Saigon fall, we watched the "boat people" as they tried to make their escapes, and we watched the killing fields spread throughout Laos and Cambodia.

No longer did we belong to our great society. We felt isolated and alone. We tucked the war inside us, as neatly as we could. We kept our feelings and experiences to ourselves, only sharing them with a trusted few. Slowly, ever so slowly, did we come to realize the severe damage this war had inflicted on the soul of our nation and to ourselves.

Many of us went for years without knowing what was eating at us from inside the depths of our minds. We suffered silently with flashbacks, nightmares, and intrusive thoughts. These problems invaded every aspect of our lives, inhibiting our personal relationships and subjecting many of us to the singular world of isolation. Many found that they were no longer in control of their emotions. They felt incapable of giving or recieving the love they so desperately needed. Many suffer from guilt resulting from what they believe they did or failed to do. Alcohol and drug abuse took their toll on many of our veterans. To this very day there are many, many veterans out there suffering from Post Traumatic Stress Disorder that have not been diagnosed or treated for this very serious problem.

PTSD has taken and ruined many lives over history. It is as old as war itself and in many ways, more cunning and ruthless than the most deliberate of enemies.

If there is only one thing to be stressed to our veterans about PTSD it is that its an HONORABLE condition. They



suffer from it as a result of fighting for their country. It knows no race, creed, color or rank. It is indiscriminate. It's only criteria is that you spent enough personal time in the hell of combat to meet its prerequisites.

Now, three decades later, I am coming out of my shell and into the light of reality. I have been diagnosed with PTSD and I am recieving proper treatment. I now know what's been wrong with me and I'm starting to feel much better. So good in fact, I think I'll go to my outfit's reunion. Perhaps I'll recognize some old buddies that I fought with and find out I'm not really alone, that there are others who share my feelings and understand what I've been through.

Jim, is that you I see sitting across the table from me? It is you, you staring into space. You, yes, you, with "The Thousand Yard Stare". I remember, I remember I SEEN YOU in action at the artillery site, as you were overrun at your listening post, as the enemy chased you back to the perimeter. I SEEN YOU throw grenades and empty the magazines in your rifle as the enemy blew their whistles and bugles in an all out charge. Yes, I remember, I SEEN YOU take a round and administer aid to the more seriously wounded soldiers. Have you been diagnosed with PTSD? You haven't? Let's walk down the hill together, again. This time we'll go to the nearest Veterans Administration Hospital, then we'll go to that Big PX. Yes, yes, it does seem like only yesterday, doesn't it?



KHANH DUONG, Viet Nam (101-IO) – Devastating desserts are being served in Viet Nam. The chefs are the paratroopers of the 1st Brigade, 101st Airborne Division.

Their kitchen is the jungle. Gourmets would shudder at the conditions. The walls are savage green in daylight. With nightfall they become grotesque images. The floor is dirt. It quickly mires in the rain. Above the sun provides a constant temperature – hot.

Each paratrooper helps prepare the desserts in the jungle kitchen. The menu is selected at battalion level, the rifle companies concoct the toxic delights.

The treats come in three forms – Claymore Parfait, Shrapnel Suzette, and Ambush Jubilee. Company A, 2d Battalion, 327th (Airborne) Infantry does the cooking.

The recipes are simple:

CLAYMORE PARFAIT – 3/4 pound of C-4 plastic explosive, one steel plate, an electric fuse to light when serving. Delicious up to 100 meters.

SHRAPNEL SUZETTE – one dozen M-79 grenade launchers, a bag of hand grenades, one radio on the artillery's frequency. Sprinkle lightly with mortar fire. Guaranteed to "tantalize" the most reluctant diner.

AMBUSH JUBILEE – A jungle trail, 10 hidden positions, one crossfire of M-60 machine guns mixed with interlocking M-16 rifle fire and unsuspecting Viet Cong. Surprise essential for perfection.

The chefs are professionals. Their hours are long, the work arduous.

Sergeant First Class Roy E. Shelnut, a veteran from Fayetteville, N.C., pauses along a trail to check his position on a worn map. This is his third tour in Viet Nam. The first two were with the Special Forces.

Leaning against a tree as his squad destroys a VC fishtrap in the rushing stream below, young Sergeant Donald Dreiling, Portland, Ore., knows the way to find Charlie is to find water.

Lean Staff Sergeant James Bailey, Rock Hill, S. C., is concerned about his sick son back in the States, but he does his job well. He leads his men on an early morning patrol while the mist hangs across the jungle valleys. Like many in the 101st, he volunteered to serve in Viet Nam because he feels this is where a soldier should be.


Fire team leader, Sergeant Manuel Gomez, Harwich, Mass., harshly corrects his men's mistakes – mistakes that can cost a life. At proper times he jokes with his men. They respect him.

After a punji stake punctured his leg, Private First Class James Triplett, Roanoke, Va., walks all day, talking of joining the battalion's reconnaissance platoon because he wants even more action than he's getting.

The diminutive frame of Private First Class Donald Conely, Warren, Minn., is 103 pounds of airborne fortitude. The others tease him about being the only man in Viet Nam whose pack is wider than he is. Every day he trudges with that pack, nearly half his own weight, dreaming of the good old "cold" days in Minnesota.

War for them is a vocation, not a passion. Ordinary men rising to extraordinary efforts in serving the enemy their bitter desserts.




The paratroopers silently maneuvered to a vantage point above a small Viet Cong training camp to observe the enemy's activities.
