Ivan, Check the lower right corner of the picture. I am the one carrying the stretcher in front. This was in Co D 1st Bde 101st ABN area at Dak To. Gen Pearson was the Bde Cmdr. I also have a LTC that works at work with me. He was an E7 up there at the time. In the back of me - is a Chinook. I was out to Dak To, but don't have any pictures. The two guys in the chopper were too close to the bombs when they came in and it fractured all their bones. The NVA also had a 3 story underground hospital complex there. This Chinook never made it back. The top left is the Huey we used to go out on an operation in the Meekong Delta, close to Mi Lai. The 3rd Chopper got hit by a North Vietnamese bazooka. I have a few other pictures scattered around, and want to put more out there. I have some pictures of Westmoreland coming out to our location back then. He always showed up with his crew of spit-shined boots and all kinds of support choppers. More were taken down close to Ben Cat. Do you remember the road and Ben Cat area, we lost a few casualties on that road - a Sgt Davis and Lt that was driving with him. One of the Plt Sgts got stuck in the rice

paddy head first. The 2 1/2 truck in back of us did not make it. They hit a 500 pounder. The EOD person that was in charge of that action doesn't live too far from me. I could go on, but I would be writing a book. I am glad that you stopped by, looked at the

site, and asked the question. Thanks and God Bless You. Charles

Dad used to write us regularly and one of the stories I remember best was when Gen. Westmoreland came to visit Phan Rang.

They had just completed all the construction on the P training area when Gen. Westmoreland came for a visit. Dad had all the staff standing by (LTC Joiner was probably among them) when Westmoreland arrived.

Dad reported to him and the General acknowledged him, saluted and continued walking. It seems the General's pilot was late that morning making their arrival in Phan Rang late and General Westmoreland wasn't happy - in today's terms 'he wasn't a happy camper.'

Dad took him on a tour of the base and pointed out the new facilities they had for training. Westmoreland's reply was something to the effect "Colonel I thought I gave orders that no permanent facilities were to be built at Phan Rang." Dad respectfully gave him a "yes sir" and they continued with the tour.

As dad relates it he showed him something else and Westmoreland didn't like that either.

Finally, he decided to give him some good news about something that was happening within the brigade and the General stopped him and said "Colonel, do you realize you're talking about classified information in front of a civilian?"

From that point on I can't remember the conversation verbatim but it went something like this:

Dad said he had nowhere to go but up from there so he said "Sir, I've worked for the General before and I wouldn't think the General would have anyone traveling with him who wasn't cleared to hear the same information he was."

He said Westmoreland looked at him for a minute, smiled and then said, "You're right, you have worked for me before and I wouldn't have anyone on my staff who didn't have a security clearance."

After that they finished the tour and returned to the airfield where General Westmoreland put his arm around dad, to everyone's amazement, then shook hands, they saluted and he got on his plane and left. I think it was after that dad became known as "Peacemaker."

Just an interesting bit of trivia to add to LTC Joiner's account of his time in Support Command.

An ironic sidebar to LTC Joiner's memory of dad saying "Joiner, I don't care how you do it, get that P training straightened up and get some facilities built," five years later I was a young Airborne, Infantry Second Lieutenant at Ft. Campbell and got assigned to the post MP company for duty in the stockade as an Assistant Correctional Officer running the rehabilitation center.

I got called in by the Correctional Officer and told "Sunday, the 101st is coming back to Ft. Campbell and you have to move out of your facilities at Clarksville base. I don't care how you do it but I want you to take this couple of acres adjoining the stockade and build a new rehab area. I got it done by hook and crook, building a two million dollar rehabilitation center without it costing the Army a penny and when it was done LTC Ed Pitts said "I don't know how you did this and I haven't asked any questions. I just hope we don't go to jail." My reply was "We haven't done anything illegal sir, just done a realignment of military assets to a mission of higher priority."

So I can identify with the complex hardships my dad gave another lieutenant a few years before.

My brother Bob gave me his copy of the First Brigade's Newletter and I would like to continue to receive them so I am forwarding my check for \$20.00 with an application for associate membership. I served with the 173d and the 101st and in eighteen years as a dependent and another twenty as an Army officer and soldier I never met a more honorable group of men than those professional soldiers I grew up around. Men like General Matheson, General Davis, COL Frank Garrison, CSM's Paul Huff, Dan Thornton, A.B. Cannon, Robert Young and many, many others, especially dad, I was proud to be a soldier in some very trying times. Thank you for putting out this magazine. I look forward to future editions.

Editor's Note: Thanks for the letter Bill! Your dad and I were friends. I am an Eastern Cherokee and he was from the West. He talked me out of a .45 Colt revolver one night 'cause he said he needed it more than I did. Quint was a great man and a great officer.


Sir, The 13th Bomber Squadron has been deactivated since the Vietnam War and was recently reactivated again in Texas.







# **NOW HE'S READY**

"I don't care if you fought in World War II, Korea or the Dominican Republic, you've never seen anything like this. And before you leave here in five days, you'll have a good idea of what to expect from Charlie."

These words greet every 101st Airborne replacement at the Screaming Eagles' Phan Rang Replacement Training School and alert him for his rendezvous with destiny.

Deep in the heart of the famous 1st Brigade of the Army's 101st Airborne Division's base camp is an encampment circled with bunkers, booby traps, punji stakes and mined civilian bikes. It is one of the most unique training camps in the United States Armed Forces system, because here a man meets the true reality of the war against the VC, before he is thrown into battle.

It matters little to Cadre of this "Stay Alert Stay Alive" unit that the incoming trooper is a private just in from jump school or a West Pointer just in from Ranger School. Everyone has a lot to learn here and everyone will be taught the same way, the hard way.

From the dawn of the first full day in camp each and every replacement feels he has met the challenge of his life. The heat of the country forces him to drink more and more water, the drive of the combat tested cadre makes him walk faster and longer, and the reality of where he is makes him strain to hear every word and see every demonstration.

Before he leaves for his unit and the line the new Vietnam Combat man will direct artillery fire from a hill held by ARVN troops. He will fire the weapons he'll be armed with and some of the enemies. He will see and learn to detect the major VC booby traps and how and why they use punji stakes and he will patrol an area six miles from base camp and return that night for an all night ambush. He will join the other replacements on a live fire range so real the Cadre carry loaded rifles in case of attack.

He sweats, he cusses, he gets scratched and cut. He learns how hot the glaring Asian sun can get and he learns fast that a short cut could cost him a leg or his life. The greatest fear is the sound of battle, he is told and the day he runs the live fire course with machine guns, grenades and M-79 rounds going off all around him he realizes how true this is.

But as his face turns from sunburn to bronze tan and his water consumption drops from seven canteens a day to two, he becomes keen in his ability; he senses a secure know-how and his already professional pride has blossomed into a proud fierce fighting man.

As he stands in the final replacement company formation he is just a little taller, a little older and a lot smarter. The sergeant who made him hurt all over stands in front of him and says, "I've taught you what I know from experience, now go get Charlie and don't forget, Stay Alert and Stay Alive." The trooper extends his hand and says, "Thanks Sarge."

When the man deploys to his unit and prepares for his baptism of fire there are people who know he is the best fighting man in Vietnam, prepared for his rendezvous with destiny. The cadre at repl company, himself and most of all Victor Charlie, the enemy.

Human bait was used to spring a successful trap on the Viet Cong north of Tuy Hoa, as the 1st Brigade of the Army's 101st Airborne Division continues to seek out the running enemy.

#### **NEW LIBRARY DEDICATED**

Brig Gen Pearson noted that "the opening of the library is a major step in the progress of our installation and in the benefit and entertainment of the troops."







#### **LRRP MAKES CONTACT**

Killing Viet Cong is not always the mission of the American paratrooper in Vietnam. The Long Range Reconnaissance Patrol of the Army's 1st Brigade, 101st Airborne Division has the job of landing by helicopter, deep in Viet Cong territory to observe and extract information about the enemy without engaging with him. The latter is not always possible.

The night air rising from the dense jungle below was hot and moist, as the five man LRRP team descended toward an isolated clearing deep in the mountains of the Tuy Hoa area. At the same moment the fifth man placed his feet on the damp grass of the landing zone, all hell broke loose from the hillsides bordering the clearing.

Viet Cong elements of overwhelming size were firing directly upon the five man team. SSgt David Skau, Old Saybrook, Conn., immediately gave the signal to the team to disband and attempt to infiltrate toward another clearing some 125 meters away.

At the same time two forces of Viet Cong left the hillside coming toward the paratroopers. The fire lessened but still the team could not maneuver.

Upon seizing the situation the helicopter pilots directed the escorting gun ships to attack the surrounding highland. This gave the team on the ground a chance to separate into the jungle.

Sgt James Tadlock, Dallas, Tex., dashed through the undergrowth. As he raced for the alternate clearing he almost trampled three Viet Cong that circled the teams position when the helicopter landed. The sergeant's M-16 burst into a blaze of bullets as he leaped over the three, now dead, VC bodies.

The team leader, Sgt Skau, raced along a winding path when two VC started firing less than 15 meters from him. The VC came forward slowly. The veteran trooper rose to one knee and fired. His weapon jammed. The enemy was upon him when a sheet of fire came from the trail to his rear, as his slower moving radio operator had come along just in time.

In about twenty minutes the five were reformed at the alternate clearing. There was no place else to go. This was it.

As the team radioed for the helicopter to land the Viet Cong attacked. The battle lasted for nearly an hour as the five troopers formed a circle perimeter, hugged the ground and fired.

The helicopter gunships brought fire directly upon the LZ but after a few minutes they could concentrate on the outer limits of the clearing.

After three attempts, the team was extracted and headed back to safe territory.

The five man team performed well, but their mission was not accomplished, they made contact.

#### **SAY UNCLE**

"Say Uncle!" No, not part of the bitter battle of the 101st Airborne Division, just part of a conversation between Pfc Charles G. Springle, Angier, N.C., a member of Headquarters Battery, 5th Howitzer Battalion, 27th Artillery Survey Section and his uncle Captain James D. Springle, a member of the 184th Ordnance Battalion, Qui Nhon. The 5th Howitzer Battalion, 27th Artillery is attached to the 1st Brigade, 101st Airborne Division.

#### **WEAPONS FOR VIETNAMESE**

"This not only means more weapons for the Vietnamese Armed Forces in Tuy Hoa, but that many less for the Viet Cong."

With these words, Brig Gen Willard Pearson, Clairton, Pa., Commanding General of the 1st Brigade, 101st Airborne Division, while speaking at a small ceremony in Tuy Hoa, presented 31 weapons to Lt Col Ba, province chief of Phu Yen province.

A total of 60 weapons have thus far been given to the province troops, who had worked so successfully with the Screaming Eagles in operations in the Tuy Hoa sector.

Lt Col Ba praised the gallantry of the 101st and the Brigade's practice of giving U.S. made weapons to the Vietnamese armed forces to add to their fighting capabilities.

#### **CURFEW HOURS**

The following message from Ambassador Henry Cabot Lodge and General W. C. Westmoreland is quoted for compliance.

"The government of the Republic of Vietnam has imposed a curfew from 9 p.m. to 5 a.m. which is effective immediately. All Americans not on duty are expected to observe this curfew and to remain off the streets. Personnel who are required to be out on official business during curfew hours must stop if requested to do so by Vietnamese police or military authorities of U.S. Military Police and produce proper identification. Until further notice American personnel should curtail all unnecessary activities and if possible remain off the street during non-curfew hours."

#### **COMBAT STEAMER**

The Combat Infantry Streamer was awarded to Companies A, B, and C of the 1st Battalion (Abn) 327th Infantry, 2nd Battalion (Abn) 327th Infantry and the 2nd Battalion (Abn) 502nd Infantry of the 1st Brigade, 101st Airborne Division, as was noted in last's week issue. To attain this coveted award each unit must have had 65 per cent of its TOE strength awarded the Combat Infantryman's Badge.

The effective date was listed as September 1965 in Brigade General Order Number 99 and was awarded by orders of the Commanding General under the provisions of paragraph 206b AR 672-5-1. (Editor)

#### **NEW PUBLIC LAW**

"The President has signed Public Law 89-368 which authorized Armed Forces personnel serving in a combat zone to send gifts tax and duty free to the extent such gifts in any shipment do not exceed fifty (50) dollars in aggregate retail value in the country of shipment if such articles were purchased in or through authorized agencies of the Armed Forces of the United States. Pending issuance of treasurys and departmental regulations on this matter request you inform all personnel entitled to this privilege to clearly inscribe on the outer wrapping of all such gifts the following: "P.L. 89-368 value less than fifty (50) dollars." Detailed regulations will be issued in the near future. For your information these regulations will probably exclude repeat exclude, exemptions applicable to alcoholic beverages and tobacco products."

# **DIPLOMATS AND WARRIORS ALL**

#### **ABOVE THE REST**

The 1st Battalion (Abn) 327th Infantry conducted an awards ceremony at their battalion headquarters on 10 April 1966.

#### **SECOND TO NONE**

During the period 31 March through 6 April 1966, the 2nd Battalion (Abn) 327th Infantry Hawk teams, with an attached platoon from Co A, 2/327 Infantry conducted night infiltration into enemy occupied territory and conducted reconnaissance and surveillance operations for two days which led to offensive actions by the remainder of the battalion.

In the subsequent battalion operation, the "We Aim To Kill" troopers conducted search and destroy operations, which resulted in 9 VC dead (body count), 4 VC killed (est), 1 VC wounded, 45 VC suspects captured, 1 Thompson submachine gun captured and the capture of a small enemy ammunition cache. Friendly casualties were light.

#### **STRIKE FORCE**

On 7 April 1966, Lieutenant Colonel Henry E. Emerson, battalion commander of the 2nd Battalion (Airborne), 502d Infantry presented gifts to an orphanage in the city of Tuy Hoa. The children and Nuns in this orphanage are the ones who were extracted from Hoi Tin by "B" Company earlier in the year. The gifts consisted of over 30,000 piasters, assorted clothing sent from the United States, school supplies and shoes.

#### ON THE WAY; WAIT

Another "first" was recorded by the 2nd Battalion, 320th Artillery, when on 1 April, Battery A moved its howitzers and 1/4 ton vehicles into a firing position near Dong Tre using CV-2 (Caribou) aircraft. This move was conducted in order to support operations by the 1st Battalion, 327th Infantry in the Dong Tre Le Hai area. Subsequent resupply to include 50 tons of ammunition have also been accomplished utilizing CV-2's. This firing position proved lucrative when on the night of 5 April, Battery A fired in response to a CIDG request and achieved 30 VC KIA confirmed by body count.

#### **UNITED WE STAND**

1st Sgt Floyd C. Garwood of Malden, Wash., was recently appointed 1st Sergeant of Service Battery, 5th Battalion, 27th Artillery. Entering the Army in January 1951, 1st Sergeant Garwood served with the 40th Infantry Division in Korea until after the Armistice. As a "Redleg" he has served in several armored and anti-aircraft units. Reporting from an assignment in Verona, Italy, 1st Sergeant Garwood brings a long career of outstanding records in operations, intelligence, and personnel administration to the 27th.

#### **ALWAYS THERE**

Captain Billy R. Cook, Movements Control Officer for the Brigade forward area, was promoted recently to his present grade. Captain Cook and his enlisted assistant have kept the flow of personnel and supplies between Phan Rang and Tuy Hoa moving in a very efficient manner.

#### **17TH MULE**

Shortly after arriving in the Tuy Hoa area, A Troop was given the tremendously large task of screening the northern flank of the 1st Brigade. The mission was gradually increased to include search and destroy operations and saturation patrols. To facilitate the accomplishments of this mission a provisional infantry platoon was added to the Troop. The new platoon was filled with volunteers from the other battalions in the brigade who were CIB qualified.

#### **ALWAYS FIRST**

Brigade Headquarters is busily preparing for the upcoming IG inspection to be conducted in the rear area on 12 April 1966.

# WHEN IT TOO TOUGH FOR THE REST CALL THE BEST

The 326th Engineers of the 1st Brigade, 101st Airborne Division have been working laboriously laying concrete slabs for future billets in the rear area. They now have a new project; rebuild the Commanding General's house, which burned to the ground on 5 April 1966.

#### **NEW CHAIRMAN ELECTED**

Nguyen Huu Kee, 28, was elected as the new chairman of the Friendship Council by a vote of 11 to 5 during the committee's monthly meeting held at the province chief's home on 5 April 1966.

The Friendship Council, dedicated to law enforcement, price control, and friendly community relations between American forces and the Vietnamese Army and civilian populace, is composed of representatives from the Army, Air Force, RMK, USOM, the province chief, Chief of Police and several prominent Vietnamese citizens from the Phan Rang area.

When notified of his election through an interpreter, Mr. Ke had this to say, "I am reluctant to accept the position because of my young age and inexperience; however, because of the kind words said about me by the members of this council, I cannot refuse the chairmanship. I will strive to better the relationship between Americans and Vietnamese, both civilian and military."

Lt Col Phelps R. Womble, commanding officer of the 1st Brigade's Support Battalion and outgoing chairman of the council, nominated Mr. Ke for the position and expressed confidence in Mr. Ke's capabilities as chief mediator for the council.

#### **LADIES GALORE**

As the Tiger Force of the 1st Battalion (Airborne), 327th Infantry called for artillery support, a high flying forward observer for the Screaming Eagle unit relayed the message to Battery A of the 2nd Howitzer Battalion, 320th Artillery. Once again the warning of the "Nomads of Vietnam" rung true. "There is no escape, no safe place to hide, the Eagle strikes swiftly and silently bringing certain death."

"I got a coffee pot, a pound of coffee and three pounds of candy," shouts Pfc. Jeff Akbacauskas, Sunnyvale, Calif. Sitting at one side of the jubilant group is Pfc. Robert A. Gallegos, Denver. He holds a birthday card and letter from his wife. "I live day to day to hear from home," he says. He's typical.

Many packages from next-of-kin of buddies lost in battle arrive too.

SAIGON — Three states, Connecticut, Louisiana and Illinois have voted bonuses in connection with the Vietnam war. The covering active duty awards, covering active duty personnel, discharged veterans and surviving next-of-kin, range up to \$1000.

In 1965, Illinois authorized payment of \$100 to residents with active duty tours on or after January 1, 1961 and who earned the Vietnamese Service Medal. A serviceman must also prove that he resided in Illinois during the year preceding his entrance on active duty.

Next-of-kin (spouse, children, parents, brothers and sisters in that order) may collect \$1,000 if the deceased dies of Vietnam service-connected causes even

service-connected causes even if the serviceman had received the \$100 bonus prior to his

the \$100 bonus prior to his death.

Claim forms are available from the Illinois Veterans Commission, 221 W. Jefferson St., Springfield, Ill. 62705. The deadline is July 1, 1970.

Louisiana passed a bill granting a \$250 bonus to state residents who served in the Vietnam combat area between July 1, 1958 and the end of the Vietnam campaign. However no payments will be made until the hostilities terminate.

The Louisiana bill contains a survivors' benefit payment of \$1,000 to unremarried widows, children under 18 and parents of servicemen (in order of eligibility) who are Vietnam casualties provided the deceased was a qualified resident of the state prior to his entry into the armed forces.

Claim forms may be acquired from the Louisiana Department of Veterans Affairs, Vietnam Bonus Division, Old State Capitol, Baton Rouge, La., 70801.

Military service anywhere in the world since January 1, 1964 will earn Connecticut residents a \$10 bonus for each month of active duty, with a \$300 ceiling. To collect while on active duty, the serviceman must have at least 30 months of credited service while honorably discharged veterans may collect whatever bonus is due them since the established base date with a 90-

day minimum. The minimum residence requirement for eligi-bility is one year before entry

into service.

into service.

Next-of-kin may receive the survivors' bonus if the deceased died as a direct result of the performance of military duty. Grandchildren and parents must have been living in the state one year prior to apply for the benefit. In the event the servicement was unmarried bis. serviceman was unmarried, his

parents receive the bonus.

Survivors of honorably discharged veterans will be paid in accordance with the span of countable service. The maximum benefit to surviving nextof-kin is \$300.

Claim forms are available from the Office of the Treasurer, Vietnam Bonus Division, 15 Lewis St., Hartford, Conn. 06115. The deadline for filing is three years after the end of the war.

## Tiger' Recalls 'Charlie'

PHAN RANG — Twenty-year-old paratrooper Spec. 4 Richard W. Ammons, High Point, N.C., held his bandaged arm up and pointed to his burned fingers: "The son-of-a-gun who shot me was four feet away."

Ammons leaned back on the Pard Surgical Hespital bed at

Antimons realised back of the 2nd Surgical Hospital bed at Chu Lai, lit a cigarette and recalled the afternoon he scored an enemy kill in Operation Wheeler.

"It was a clear, warm after-noon and eight of us had been moving along without finding any sign of 'Charlie,'" he said. any sign of Charlle, "He said."

"I was walking point for the patrol and stopped when I came to a Y. I looked around and didn't see anything when this VC leaped up from behind a bush and fired."

The enemy bullet crashed through the handguard of Ammons' M-16 rifle, entered his left wrist, cut across the top of the bone and went out above the elbow.

"It didn't knock my weapon out of my hand," said Ammons. "I jerked my rifle up and fired a full magazine into 'Charlie.'"

a full magazine into 'Charlle.'

Ammon's slack man, Spec. 4

Dallas Rogers, Lansing, Mich., lunged forward, grabbed Ammons and dragged him back.

Pfc. Harold Fischer, San Antonio, Tiger medic, helped Rogers get Ammons behind a dike and began bandaging the wayned. wound.

"Fischer kept talking to me," "Fischer kept talking to me," said Ammons, changing positions on the hospital bed. "I don't know what he said. He just kept talking, telling me I was going to have it made in the hospital, maybe even go back to the states. He just kept talking as he gave me a shot. talking as he gave me a shot of morphine. Fischer is the greatest."

Ammons, who recently extended for another six months with the Tigers, looked at his arm and the powder burns on his fingers: "You know, depending on how long it takes this hand to heal up, I might extend for another six."

Ammons received his third Ammons received his Purple Heart for the wound.
"Of course, I could go home and quit," he said. "I've done better than my dad in World War II. He was wounded only twice."

# Some Booby Traps Require Two Checks

PHAN RANG - Two Minneapolis paratroopers in the 101st Airborne learned suspected booby-trapped objects require a double investigation.

During Operation Wheeler north of here, C Co. of the 1st Bn. (Abn), 327th Inf. approached a suspected Viet Cong village. They decided to give the area a careful search.

"In one of the huts I saw a rucksack tucked up in the

rafters," said Pfc. Arthur Kottke.

Aware of booby-traps, Kottke warned other paratroopers to stay away while he and Pfc. Maurice Northrup investigated the pack.

"We tied a rope to the rucksack, walked back a safe distance and yanked it down,"

Northrup said. Nothing happened. Cautiously the two men approached the rucksack, carefully probed it and then opened it. 'We found two NVA uniforms.

we round two NVA uniforms, a poncho, underwear, a mess kit, a cigarette lighter and a USMC jacket," said Kottke. "A fountain pen in a uniform pocket had 'Hanoi' inscribed on the barrel."

The two paratroopers carried the rucksack to platoon leader, Lt. John Borgerding, Seattle. "Did you check it for booby-traps?" asked the lieutenant.

"I sure did, sir," said Kottke

reaching into the rucksack to pull out the uniform. Kottke yelled, yanked his hand out of the pack and dropped it. Northrup asked what was wrong.

There's something in there," Kottke said.

Northrup emptied the pack and shook out a scorpion.

Pfc. David C. Thompson, Baltimore, felt the cold sweat roll down his face as a VC pointman walked down the trail toward him and others from B Co. of the 1st Re. (Ahp.) 292th Lof

walked down the trail toward him and others from B Co. of the 1st Bn. (Abn), 327th Inf. "My heart was in my throat when 'Charlie' stopped not three feet in front of my position and motioned others to follow," said Thompson as he recalled the incident. "I waited, hoping the enemy pointman would lead the rest of his force into the kill zone of our ambush."

As Thompson watched the motioning enemy, another VC collided with the pointman. Their bodies and equipment thudded in the night and alerted other members of the paratrooper force. Thompson opened fire, killing one of the insurgents. The others fled under the cover of darkness. Paratrooper recovered a pistol, compass and documents from the body.

"We never did learn how many more were coming down the trail," said Thompson. "The one thing I'll never forget—that sound when those two 'Charlies' bumped together."

The paratroopers borrowed a bus from local residents and proceded down the highway to-ward the village of Ap Vinh Hao.

About 2,000 yards short of the suspected collection point, two Viet Cong stepped onto the road. The paratroopers leaped off the bus with weapons blazing. One VC was killed and his weapon captured. The other fled into the dense underbrush beside the road.

portation Service brought in some 20,000 tons of supplies and equipment aboard five ships.

The 101st Airborne Division was activated at Camp Claiborne, La., on Aug. 16, 1942. During World War II, the division participated in the Normandy invasion. Nearly 7,000 officers and men parachuled into ficers and men parachuted into occupied France to clear the way for the 4th Infantry Divi-sion's successful Utah Beach invasion.

Later the Screaming Eagles parachuted into Holland in the war's largest airborne operation. Their mission was to secure and hold the southern third of a cor-ridor from Eindhover to Arn-

heim.

Then the troopers held the town of Bastogne, stopping the German thrust toward Brussels. Surrounded by troops from eight German divisions, the Screaming Eagles held out. After a week of heavy fighting, supplies were low. Then drops from C-47 aircraft were made and the paratroopers counter-attacked, driving the enemy off. Later the division helped drive the enemy back into Germany.

After World War II, the division was deactivated. Later it was used as a training unit and in 1956 it was re-activated as a self-sustaining fighting airborne unit

## VC Killed By LRRP

PHAN RANG-A 1st Brigade, 101st Airborne paratrooper of the Long Range Reconnaissance Platoon (LRRP) sniffed out and killed a Viet Cong southeast of here recently during Operation Rose

A LRRP team had found blood trails while searching an area. The trail led paratroopers into a group of huts surrounded by rock shelves and indented with tunnels and caves. Clothes covered with dried blood lay scattered around the area.

sgt. William D. Scanlan, Day-tona Beach, Fla., and three other troopers provided security while two team members searched the area. As they mov-ed into position, Scanlan detect-ed the familiar odor of fish and sauce that filled the air.

"I turned to one of the guys and told him to be alert," he said. "The smell meant that someone was in the area."

Scanlan turned again to trail-ratching and saw a Viet Cong fleeing.

"I could see the medical supplies he was trying to save," Scanlan said. "He didn't realize I saw him and ran."

Scanlan squeezed off two rounds. The enemy fell dead.

Elements of the 3rd Bn. (Abn), 506th Inf., later searched the entire area. Discovered was a hospital complex designed for 15 patients.

"Go get Rod," one trooper said. "He's the only one who can fix it."

"Rod" is Spec. 4 Donald V. Roderick, Boston, the only tele-type expert assigned to the 1st Brigade, 101st Airborne Division.

Roderick was trained at the t. Gordon, Ga., Signal School where he was graduated in the top 10 per cent of his class. He has been in the Army for nearly four years, serving one year in the Panama Canal Zone and now entering the ninth month of his Vietnam tour.

The paratrooper's primary responsibility is maintenance of teletype sets which serve the brigade's sensitive communications system. His unique job renders him on call 24 hours a day.

"The company has to know where I am at all times," said Roderick who is assigned to the Signal Co. (Provisional).

The delicate nature of the machines and the weather in Vietnam often cause the teletype systems to misprint.

"Sometimes I make five or six repairs a day," Roderick explained. "Often only minor adjustments are needed, but some problems can take hours to correct. In one instance I worked 16 consecutive hours to repair a machine."

Roderick often has been called while taking a shower and many times has been awakened for an emergency repair.

"I never know when one of those machines is going to mal-function and create a problem," he said.

Long hours accepted, Roderick enjoys his work—a combination of electronics and mechanics.

He also lauds the teletype operators who pull normal mainte-nance on their machines.

"My job is easier that way,"





#### **OBITUARY**



Editor's Note: I have had many inquiries about SGM Leo Smith. He was a great soldier and friend. This obituary is taken from the March-April 1998 "The Screaming Eagle" magazine.

Leo B. Smith (HQ 1/327 VN) of Harrison, Tennessee, passed away on August 7, 1997, at the age of 67. He played a lead role in founding and developing the Medal of Honor Museum of Military History. Sgt. Maj. Smith had been executive director of the museum from 1987 to 1996.

"His vision and work brought it (the museum) from a few artifacts toward the path of international recognition," said Pete Chaney, executive director of Veterans for Good Government.

Sgt. Maj. Smith entered the U.S. Navy at age 14. At age 16, the Navy discharged him. He later enlisted in the Army, where he served 25 years, including Korea and three tours of duty in Vietnam. His stint included serving as an airborne trooper.

He also served in the Reserve Officer Training Corps program at the University of Tennessee at Chattanooga.

In 1986, he and John H. Hill put together a plan to establish the museum. He had lifetime memberships in the 11th, 82nd and 101st Airborne Division Associations, and the 187th Regimental Combat Team.

Sgt. Maj. Smith was a life member of the VFW Post 4848 and the Alvin C. York Chapter.

He was preceded in death by his wife Billie June Smith and a son, James Smith.

Survivors include three sons, Charles Smith, Robert Smith and Arthur Smith; two daughters, Kathy Spaniel and Laura Terry; 14 grandchildren and three great-grandchildren.

## WHY PARATROOPERS?

TAKEN FROM A PAPER WRITTEN ON BOARD THE USS ELTINGE SOMEWHERE IN THE PACIFIC WHILE THE 1ST BDE OF THE 101ST ABN DIV WAS ON THE WAY TO VIETNAM IN JULY, 1965.

BUT, WHY PARATROOPERS? Paratroopers are a special breed! Many people wonder why we are wilder than other soldiers, a wildness that has been demonstrated many times, often with violence. Men join the paratroops because they can not resist the awful thrill of risking their lives in a parachute jump. Each one of us has supreme faith in our ability to take care of ourselves, whatever the odds. For this reason, we are a quarrelsome lot as we can never believe that anyone can possibly defeat us. This may be the key as to "Why Paratroopers?". Just as in WWII, when paratroopers took such a beating but never said die. Then defeated the best infantry in the world, The German Army.

Eleanor Roosevelt once stated of paratroopers--"Those nuts are over-paid, underworked, oversexed, drunken shoeshine boys." But other people, who had a closer look at paratroopers, had things like this to say, "American parachutists--devils in baggy pants--are less than 100 meters from my outpost line. I can't sleep at night; they pop up from nowhere and we never know when or how they strike next. Seems like the blackhearted devils are everywhere..." This was found in the diary of a German officer who opposed the 504th ABN INF on the Anzio Beachhead in WWII.

The Viet Cong Army that we are going to face is the best irregular army. Witnessed by their successful fighting since late 1946 and the defeat of the French Army in 1954. But now they are going to face us--the best regular army in the world-and we have never known defeat. The eyes of the world are upon us as we once again prepare to show the world the unconquerable spirit of the American Paratrooper!!
